FROM OUR GRASSROOTS BEGINNING, WE HAVE GROWN OVER THE YEARS INTO A RELIABLE AND EFFECTIVE FORCE IN BALTIMORE'S MOSAIC OF ORGANIZATIONS DEDICTED TO ENDING HOMELESSNESS. WE HAVE DEVELOPED AND NOW MANAGE FOUR MULTI-FAMILY RESIDENCES THAT ARE HOME FOR 67 WOMEN AND 4 FAMILIES. WE LEASE AN ADDITIONAL 27 SCATTERED SITE RENTAL HOMES WITHIN BALTIMORE CITY. WE PROVIDE PERMANENT HOUSING; THEREFORE WOMEN AND THEIR FAMILIES CAN STAY AS LONG AS THEY NEED AND DESIRE. HOWEVER, EACH YEAR SEVERAL WOMEN DO MOVE ON TO MORE INDEPENDENT HOUSING SITUATIONS. WOMEN'S HOUSING COALITION TYPICALLY PROVIDES HOUSING AND SERVICES TO APPROXIMATELY 115 WOMEN AND 40 CHILDREN ANNUALLY. OF THE 98 WOMEN WE SERVE AT ANY ONE TIME, 21 HAVE DEPENDENT

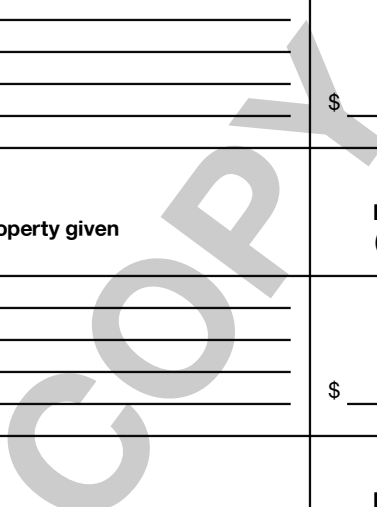
